Next year's Club raffle will be for a Henry – Lever Action 410 Side Gate, model H024-410. We are again raffling for the support of Trap Shooting a Browning BT-99 Micro Midas in 12 gauge and for pistol shooters a Kimber Custom engraved with the LLF&G name & logo in .45 caliber with a limited number of tickets sold. We will also have a Special Raffle offered by Adk Mt Outfitters of a Guided Tour of your choice for either hunting, fishing, hiking, camping, or canoeing. Drawing held at the 100 Bird Shoot in Aug.

Our programs were hurt by the COVID-19 pandemic. We were not able to hold the Kids June Fishing Derby. But the Club did stock the 500 Rainbow Trout and the Golden Trout. A \$100 prize was given to Kenyan H. for bringing in the Golden Trout. The NYS High School Clay Target League was not able to participate as the schools did not allow sports activities.

The 100 Bird Shoot was held with all the protocols in place. Had the same amount of folks as in the past. The weather was great, and two shooters got a straight 100. Looking forward to next year with the camping facilities ready for more. One project that needs to be addressed is to create a Recycle Center. Many are not aware of how the Town of Long Lake Transfer Station operates. Deposit returns benefit the local Fire Dept and should be separated.

Friday Night Trap saw the best interest this year. Believe many were only glad to get out of the house. Expanded to Wed Night to accommodate those that were not able to come Friday night and others that wanted more range time.

Donations bring in the extra funds to move the Land Purchase that doubled our property forward. We still need money to pay off our mortgage balance of \$1700, out of the \$40,000 we borrowed and improve the property. Electricity was brought in and RV outlets installed to provide expanded camping. Making way for building an Indoor Range.

As with most organizations, there are a few core members that carry the workload. Everyone seems happy with the way things operate and we are extremely fortunate to have the property in our own hands. This avoids many of the problems some ranges have. Still there are restrictions that are in place we need to be aware of and may only get worse. Now is the time to support all the organizations associated with the Second Amendment. These Rights are being eroded away piece by piece. The Long Lake Fish & Game Club continues with close ties towards the NRA, NYSRPA, and SCOPE. Regardless of the negative goings on within the NRA, they are still out there fighting. As well as Gun Owners of America, Second Amendment Foundation, National Assoc. of Guns Rights and many more.
